

Terms & Conditions

By completing the Online Registration Form, you (the "Participant") agree to be bound by the terms and conditions set out below.

1. The Promotion

- 1.1 This Promotion is part of Jewson's Trade Cup campaign and provides Participants with the opportunity to win prizes.
- 1.2 Subject to these terms and conditions, Participants have the opportunity to win a prize in our prize draw by completing the online registration form available on our website www.jewsonrewards.co.uk/TC26 (the "Website"). In addition to a single automatic entry into the prize draws upon registration, Participants which make an Eligible Transaction during the Promotion Period will be sent play codes to be used on the Jewson penalty shoot-out gamification.
- 1.3 The Promoter is STARK Building Materials UK Limited, trading as Jewson (with registered company number 01647362) whose registered address is at Merchant House, Binley Business Park, Harry Weston Road, Coventry, CV3 2TT.
- 1.4 By participating in this Promotion, you confirm that you are eligible to do so and are eligible to claim a prize if you are chosen as a winner. The Promoter may require you to provide proof that you are eligible to enter this Promotion and/or to claim a prize.
- 1.5 Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon registration.

2. Promotion Period

- 2.1 This Promotion begins at 00.01am on 8 June 2026 and ends at 11.59pm 19th July 2026 (inclusive) (the "Promotion Period").
- 2.2 Failure to complete the Online Registration Form by 11.59pm 18th July 2026 will preclude your participation in this Promotion.

3. Eligibility and restrictions

- 3.1 This Promotion is open to UK residents aged 18 or over which are a Jewson credit account or Jewson cash account holder (each an "Account") during the Promotion Period, provided:
 - 3.1.1 Those Account holders are not excluded under paragraph 3.2 below; and

- 3.1.2 The Account holder has completed the Online Registration Form available on the Website before 11.59pm on 18th July 2026.
- 3.2 The following are excluded from, and may not participate in, this Promotion:
- 3.2.1 Accounts held by public sector organisations or housing associations;
- 3.2.2 Employees of the Promoter (or any other company within the Promoter's group) (an "Employee"), an Employee's immediate family, their agents or anyone else professionally connected with this Promotion;
- 3.2.3 Any holders of a trade account or trade cash card account of any brand of the Promoter other than Jewson; and
- 3.2.4 Account holders which:
- (a) have their own Jewson account manager; and/or
 - (b) benefit from a rebate scheme with the Promoter.
- 3.3 The decision as to who may participate is at the discretion of the Jewson Marketing Department at starkmarketing@starkbuild.co.uk whose decision shall be final and binding.
- 3.4 The Promoter accepts no responsibility for Online Registration Forms that are incomplete, inaccurate, not received due to incorrect information being provided or which are submitted prior to or after the Promotional Period. Equally, the Promoter accepts no responsibility for any transactions which, but for the Participant's failure to complete the Online Registration Form on time and/or in full, would have constituted an Eligible Transaction for the purposes of this Promotion.

4. How to Enter

- 4.1 To enter the prize draw, customers must complete the Online Registration Form by scanning the QR code available in branch or by clicking on the relevant link on one of Jewson's social pages or its website (<https://www.jewsonrewards.co.uk/tc26/welcome>).
- 4.2 Once registered, participants which spend at least £100 exc VAT in-branch on Jewson goods during, and for in-branch collection within, the Promotion Period (an "Eligible Transaction") will receive play codes for Jewson's online gamification for a chance to win an instant-win prize.
- 4.3 The Online Registration Form must be completed by the Participant accurately, including the provision of full, current and correct contact details by 11.59pm 18th July 2026.

- 4.4 No more than two (2) Eligible Transactions per Participant per day will be permitted. Any transactions in excess of this daily limit will be excluded from the Promotion and will not be eligible to receive any play codes.
- 4.5 Where a registered Participant has made an Eligible Transaction, they will be notified by email on the following day after their order is placed with their play codes. The play codes can be redeemed by entering those play codes into the penalty shoot-out gamification on the Website.

5. Prize, winners and notification

- 5.1 Upon completion of the Online Registration Form and each time an Eligible Transaction is made thereafter, the participant will receive a single automatic entry into our weekly prize draw to win one of the available prizes, being:
- 5.1.1 two (2) tickets to a football match;
